- Updated curriculum vitae
- Letter of intent
- Three letters of recommendation
 - Preferred: one from a pediatric pharmacist
- Pharmacy school transcripts
 - GPA > 3.5 preferred
 - Pass/fail programs: >10% class ranking preferred
- Interview required
