Referral Guidelines

Developmental Delay/Regression

Referring provider's initial evaluation and management can include:

- Developmental surveillance- please see AAP guidelines http://aappolicy.aappublications.org/cgi/content/full/ pediatrics;118/1/405
- In addition to the developmental evaluation, a medical diagnostic evaluation to identify an underlying etiology should be undertaken. This evaluation should consider biological, environmental, and established risk factors for delayed development.
- Vision screening and objective hearing evaluation;
- Review of newborn metabolic screening and growth charts;
- Update of environmental, medical, family and social history for additional risk factors are integral to this evaluation.
- Referral to and input from early intervention specialists (eicolorado.org) and physical, occupational and speech therapists, as appropriate.

When to initiate referral:

- Evidence of significant delay in two or more areas of development
- Evidence of regression
- Head size crossing percentiles or baseline microcephaly
- For delays in a single area of development-lack of progress toward typical development after three to six months of intervention

What records can referring provider send?

- Growth charts
- Results of developmental screening tools
- Early intervention and therapy reports

- Newborn screening results
- Any medical information about other family members with developmental concerns
- Results of vision, hearing screenings

Children's Colorado's workup will likely include:

- Detailed medical, birth, social, family and environmental history will be obtained.
- A general medical examination and detailed neurologic examination will be performed.
- Head imaging for abnormal or abnormally growing head
- Genetic testing as indicated.
- Referral to other clinics as indicated may be recommended (e.g., Neurosurgery, Neurodevelopmental Behavioral Pediatrics)

- Patients with developmental delay or regression can be evaluated by any of our general pediatric neurologists.
